General Information

Exhibits will be in One Particular Harbour (OPH) North & East on the 9th floor of the resort. Exhibitor badges may be picked up on Friday at the registration desk if not found at the assigned exhibit table. They'll be distributed if time allows.

All registered exhibitors may partake of the provided food and beverage on Friday and Saturday. The LLRS requests that meeting participants be allowed to go through food lines and/or be seated before exhibitors serve/seat themselves.

The provided seating in the meeting areas is for *the participating healthcare professionals*. This includes seating at the round tables in OPH and the classroom-style seating in Compass Rose North & East.

There will be theatre-style seating in the rear of Compass Rose North & East for exhibitors but it will be limited and is first come, first served.

Your exhibit and the space your team takes up may not overflow your provided area as it will interfere with the exhibit(s) next to yours. **Do not pull chairs from the round tables to your exhibit table.**

Participants should not be approached during the general sessions/symposia (Compass Rose North & East). Use the dedicated meal/break time to converse with the participants.

Exhibit Set Up

The exhibit tables will be approximately one foot (12 inches) from the wall and each exhibitor will only have the surface area of the 6'x30" table(s) and behind it to place a display. The exhibit area is carpeted.

Your exhibit and the space your team utilizes may not overflow your provided area as it will interfere with the exhibit(s) next to yours. Do not pull chairs from the round tables to your exhibit.

You may check to see if the exhibit tables are set and labeled after 5:00 p.m. on Thursday, July 11. If the table(s) are not clearly marked with your company's name, do not set up. If you begin setting up on Thursday and do not finish, the area must be left neat and clean overnight. All exhibits must be completely set and free of trash, boxes, etc. by 7:00 a.m. on Friday, July 12.

Exhibit Set Up continued

Officially, exhibits may be set between 5:30 and 7:00 a.m. on Friday, July 12. Boxes needed for return shipments need to be stored under the exhibit tables. All exhibits must be completely set and free of trash, boxes, etc. by 7:00 a.m. on Friday, July 12.

Note: None of the meeting areas will be secured. The LLRS and Margaritaville Beach Resort are not responsible for lost or stolen items. It is suggested you take valuable items with you when you leave the area.

Exhibit Dismantle and Return Shipments

Exhibit teardown may take place between 11:30 a.m. and 2:00 p.m. on Saturday, July 13. Each exhibitor must provide its own shipping materials including boxes, tape, air bills, etc. The LLRS and Margaritaville Beach Resort will not provide shipping materials. Return shipments must be ready to be shipped upon exhibitors' departure. Items to be shipped may be left at the exhibit tables in OPH. The exhibiting company must arrange for pick up Monday through Wednesday, July 15–17. Items may be picked up between 9:00 a.m. and 3:00 p.m. each day.
